#### **Explanatory Notes to the Financial Statements**

#### Note 1: Change of Financial Reporting Period

In 2019 the WHA received permission from the Charities Directorate of the Canada Revenue Agency to change its fiscal year-end from April 30 to December 31. The effective date of the change was September 30, 2019.

This change resulted in a one-time interim reporting period of eight months for the transition period May 01 to December 31, 2019. The current financial statement reports information for a twelve-month period, January 01 to December 31, 2020 as well as for the eight-months of May 01 to December 31, 2019.

The difference in the lengths of these two reporting periods should be taken into account when comparing amounts under the two columns.

#### **Note 2: Donations**

One in-kind donation for the layout and publication of the WHA newsletter is not included in the 'Donations' item.

A receipt for income tax purposes in the amount of \$2,000 was issued for this donation.

#### Note 3: Grants

A supporting grant of \$6,000 was received from the City of Westmount.
