- I. Call to order Meeting was called to order at 3:04 pm by AB.
- II. Approval of the September 2021 JF approved agenda, CB seconded.
- III. Approval of June 2021 Minutes JF approved minutes, CB seconded.

- F. <u>Newsletter</u> CB gave brief verbal update. Newsletter was very complicated but should be ready by September. Board agreed to CB proposal to focus on architects houses in Westmount for next newsletter.
- G. <u>Oral History</u> No questions about JF's monthly report. AKGB is working on an interview and CB will contact Erin Hogg to be interviewed by JF.

IV. New business

- A. <u>Board Meeting day/time/format for calendar year</u> It was agreed that for rest of year due to COVID variant concerns, board meetings will be held virtually on first Tuesdays of the month at 3pm.
- B. Tours and Lectures CB circulated three tours to membership in 2021. Currently working on a collaborative lecture with WPL for Oct 16th 7pm Victoria Hall. It is in person and only open to library card holders.

C. Social Meeting Given requests from board members to meet in person, AB proposed a social gathering on her deck in the fall, but response was tepid. JM suggested a meeting to review new archives and will look at potential dates.

Website Report

The main change to our website over the summer was the migration of our three webbased mailboxes

In addition, the agreement with our programmer for website maintenance free of charge for a year is now over, although the last change that we asked for before the ending date has not yet been implemented. Given the complications that have occurred in part as a result of his residing in a different country and time zone, I am now looking into finding someone local who can make small changes to the site if they require more technical skill than I have. If anyone on the Board knows of people with experience in building websites who might be interested and available for this kind of occasional work, please let me know. I have been given names of two people who have worked on the City's website, but a retired person who would like to keep their hand in by volunteering would be even better (and, of course, less expensive).

I am still working on the restricted pages containing information to be available online to board of directors members only. Although I have collected and formatted all the material, I will need to consult with someone with website building experience on how to add what I've done to the website and to make it accessible only to those who have the required password.
