

Newsletter

The digital copy of the Feb.'22 newsletter was sent out by Anne. She has now mailed the print issues to certain individuals & organizations. We had 60 copies printed. Probably even less will be needed for the fall edition. Many thanks to Jane for her work as copy editor, to Anne for the distribution, and to both for their written input.

As there is not a spring lecture series, I'd like to propose the theme "Memories of Westmount" for the September issue. This would be centered on written anecdotal articles we have in the archives (many of them never published) & on memoirs/interviews which Jan has collected in the past several years. It would highlight the increased scope of this WHA project from oral history to written or spoken memories. It could also spur individuals in these challenging times to start writing their own memories. I ask for Board approval so that we can begin collecting these documents.

WHC

It isn't clear to me where the WHC is heading. The meetings have been intermittent, although the proposals for the Goode property have to be studied and responded to. Julia Gersovitz has resigned from the WHC, both as its chair and as a member. Her expertise and passion were a gift to Westmount and its heritage. As of yet, this resignation hasn't been announced publicly by the city, so please consider this information **confidential**.

In the same **confidential** vein, I sent a letter on Feb.21st to members of the WHC and PAC about 3 major concerns I have about proposals for changes to the Goode House. I am beginning to feel that the WHC is being used to rubberstamp certain political decisions. I sincerely hope that this is not the case. More details when I feel free to comment.

V. Oral History - Jan Fergus

Westmount Memories: possibly we will receive a written article by the end of March from Pam Price, but most likely not; that is an absolute deadline. If nothing is submitted, JF will prepare another excerpt from Diana Martin's memories for the fall newsletter.
